March Focus

Third Step Prayer

"God,I offer myself to thee – to build with me and to do with me as thou wilt. Relieve me of the bondage of self, that I may better do thy will. Take away my difficulties, that victory over them may bear witness to those I would help of thy power, thy love and thy way of life. May I do thy will always!"

Step 3

"Made a decision to turn our will and our lives over to the care of God as we understand him."

Step 3

In step three of AA you are making a decision: it's that simple. You make decisions all day everyday, right? Making a decision to turn your will over to God or a "Higher Power" can be just like putting on a new pair of glasses and seeing everything more clearly.

STEP THREE OF AA: TURN IT OVER

When we've taken steps one and two we have learned and accepted that our lives are unmanageable, we are alcoholics and a power greater than ourselves can restore us to sanity.

What if we were to surrender the manageability part? We can surrender a lifetime of self-will run amok by making the decision to turn it all over to a Higher Power and allow someone and something to care for us. We can stop wearing ourselves out trying to make and force everything to happen as if we were in charge of everything in the world.

Recovery is a spiritual process and step three is when the doors of hope, faith and trust are opened allowing us to once again take a deep breath feel and the serenity: a gift of sobriety. The essence of step three is turning over your will, getting out of the way, and being restored to reality, honesty, balance and peace of mind.

STEP THREE OF AA: SEEKING KNOWLEDGE

When working on step three we take a look at how acting on self-will means behaving with the exclusion of any consideration for others, focusing only on what we want and ignoring the needs and feelings of others. While we were busy pursuing these impulses, we mostly left a path of destruction behind us, and we definitely lost touch with our conscience and a Higher Power.

However, while working the third step we begin to focus our attention on seeking knowledge of a Higher Power's will for us. Making a decision to turn our lives and will over can't do anything unless we take the actions necessary to turn it over. Simply making a decision without following it up with action is meaningless. For example, you can make a decision to go to a meeting, but if you don't leave your home for the rest of the day, it won't happen, will it?

In AA there are many helpful recovery tools that have worked many times over at maintaining sobriety and a connection with a Higher Power. There's actually a very effective and simple prayer adapted from a prayer by Reinhold Niebuhr and known as the "Serenity Prayer," which can help you as you are seeking knowledge and make your decision to turn it over on a daily basis:

"God, grant me serenity to accept the things I cannot change, courage to change the things I can, and wisdom to know the difference."

With the "Serenity Prayer" you can learn to accept with serenity the current reality of your condition and that although you cannot control the choices and actions of others, you can decide how you will act in each situation. You may not be able to change some things in your life, but you can make a decision to change your willingness to surrender, trust and seek knowledge.

Third Step Hope -Deciding to Turn My Will and Life Over to G.O.D.

After 2 1/2 years of sobriety, I reached an emotional bottom. had not found a spiritual experience sufficient to recover from alcoholism.

I was in constant torment in my mind, blaming my husband for not helping me with my newborn and the household chores and feeling generally negative about life. All I did was cry and complain about my problems to anyone who would listen. I held most meetings hostage with my litany of woes.

I was attending 5 to 7 meetings a week, so I figured I was working a good program. I felt so sorry for myself that I decided maybe I should just start drinking again because I was just as miserable in sobriety as I had been drinking. In one last attempt to give this 12 step program a chance, I hit as many meetings as I could, even going back to attending Alanon meetings, in the hope of encountering a ray of hope.

In attending the Wednesday night Alanon meeting, which incidentally was the first meeting I had attended 5 years prior, when I had first come to Alanon looking for help with my co-dependency, found my ray of hope. Her name was Carol. She talked in a very simple and direct way about the power of the steps and how they had changed her life. She was a teacher and I related to her because I was a teacher and I responded very well to the intellectual approach. I remember asking her very directly in the middle of the meeting, "Are you telling me in no uncertain terms that these steps have given you a spiritual experi- help me God! I was going to give

ence and a completely new way of life?" She looked me right in the eye and confirmed that right now she had complete peace and could be completely in this moment. She could be in this meeting right now and not think about anything else but being present in this meeting. I so envied that! Even though I was in that meeting I was thinking ings. of all of the chaos outside of that meeting that was waiting to swallow me up. I got her number and decided to "interview her" to be my next sponsor.

Over latte's at Wilson's Coffee shop, and notebook in hand, I asked her if she was to sponsor me, precisely how she would do it and what she would require of me. She explained the commitment that she would make to me and that she would expect in return.

She laid down the terms and I agreed as I was desperate to do something, anything to get well. I had a new baby girl and did not want to ever put her in danger from my alcoholism. I had a marriage I desperately wanted to end or save. I really didn't know what to do any-All I knew was that I had more. reached the jumping off place in sobriety. I couldn't go on, yet, I couldn't go back. My life and sobriety were on the line and I was quite literally putting my life into the hands of this woman.

I would say that this experience of making a decision to work with Carol was Step 3 in action for me. I decided to put my life into someone else's care. I committed to work the rest of the steps with her. all the way through Step 12, so

this program my all and find out if it really worked.

I aligned my will with her will for me. I followed directions. I attended the meetings she required of me. I met with her weekly. I completed the assignments. more effort into my step work with her and less into attending meet-

I stopped trying to solve my problems by talking about them. didn't make any decisions unless I ran them past her. She gave me G.O.D. - Good Orderly Direction. I finally decided that I had a better chance of someone other than me running my life. It felt good to know that I did not have to make the decisions anymore! I put my trust in her and decided that if things didn't work out, I could blame her. But. my life (thoughts and emotions) got better! I let a complete stranger run my life and I was getting better? Wow. Yes, I was that desperate. Desperate enough to make a decision to commit my life into someone else's hands.

This third step experience has enabled me to have many more third step experiences. Allowing another human in and having it turn out wonderfully has allowed me to let God in. Who knows what will happen now if I now align my will more perfectly with my Creator?!
